Choggiung Revises Wood Cutting Policy

At their June 8th meeting, the Choggiung Limited Board of Directors voted to restrict woodcutting on corporate land to Choggiung and BBNC shareholders only.

Under new regulations, non-shareholder and commercial wood cutting permits previously sold to shareholders were eliminated.

The ever increasing use of wood as a source of heating homes in the Dillingham area has resulted in diminishing supplies of standing wood causing concern for sustenance. Optimistically, the change in policy will give the spruce trees a chance to replenish growth.

The new policy is now in effect and will be in place for the 2013-2014 wood cutting season. Although there is no charge for wood cutting permits we ask that all shareholders harvesting wood on our land get a permit to help keep track of the amount of wood being harvested.

In compliance with Alaska State law, the Board of Directors of Choggiung Limited is soliciting shareholders who wish to run for a seat on the Choggiung Limited Board of Directors. This year there are (3) three seats up for election. On the back of this letter you will find a DECLARATION OF CANDIDACY form. If you are interested in running for a seat on the board, you must fill out the Declaration of Candidacy form and return it to the Choggiung Limited office by 5:00 p.m., Wednesday, November 27, 2013. You should be aware that being a member of the Board of Directors is a serious commitment of time. If you fill out a Declaration of Candidacy and you are elected you must make that commitment. Contact the Choggiung office if you have any questions about the number of meetings and the time required.

When the Board solicits proxies for Board elections, state law requires the proxies to name the candidates. To satisfy this requirement, we are now soliciting shareholders who want to run for a seat on the Board of Directors. State law also requires the corporation to provide shareholders with certain information about the candidates who are named on the board solicited proxy form; we will ask each shareholder who submits a "Declaration of Candidacy" form to fill out an informational questionnaire. Candidates who provide the required information by Monday, December 9, 2013 will be named on the board solicited proxy form and will be eligible for the votes cast by the shareholders who sign the proxies.

Candidates who do not declare their candidacy early and who do not provide the required information will NOT be eligible for board solicited proxy votes.

All shareholders will continue to have the option of attending the annual meeting and voting in person for the candidate(s) of his or her choice. Individuals who want to solicit proxies from other shareholders may continue to do so by using "non-board solicited proxies".

By soliciting shareholders interested in running for the board and having every candidate listed on the proxy form, you the shareholder have the right to vote for the candidate of your choice.

Land Use Program

Choggiung's Land Use Program on the Nushagak River experienced a better season than seen in the past four years. Guide operators had a 25% increase of camping clients and the river saw a 90% increase for fly-in clients. In recent years the program had suffered due to low Coho returns but managed to ward off losses.

Now, it appears that the king salmon returns are on the rebound; although the Alaska Department of Fishing Game does not forecast a coho return to the Nushagak we are optimistic that increases in revenue will transpire into next year.

HRM Sports

In conjunction with Choggiung's Land Use Program, HRM Sports offered boat and tent rentals on the Nushagak during the 2013 season. The small scale operation proved to be successful and plans to expand the business will proceed for the 2014 season.



Routine Maintenance for Wind Turbine

If you live in Dillingham, you might be missing the now familiar sight of the wind turbine turning (or sometimes taking off) in the wind.

This fall our maintenance crew lowered the wind turbine for its bi-annual routine maintenance check and discovered that the blades needed some repair.

Once materials for the blades are received

and necessary repairs are made the wind turbine will be reassembled and in working order again.

The wind turbine was purchased and installed in 2010 to offset the cost of utilities to run the court house building which Choggiung Investment Corporation leases to the State of Alaska .

Operating under Quvaq LLC, the Bristol Inn and the Bayside Diner will show a profit for the fiscal year ending 2013.

PELLI hit the ground running concentrating on marketing and business development in the service and inspection business.

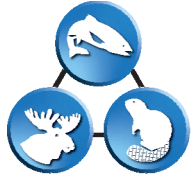
An apprentice will be sent to design school at the end of October and will be available in late November as a designer in training which will help out with the backlog of jobs waiting on design work.
