Overview:

Choggiung Ltd. is seeking qualified individuals to submit bids for a seasonal **Wood Patrol Contractor** position. The Agent will serve as an independent contractor responsible for conducting up to **12 patrols per month** between **August and April** across designated Choggiung, Ltd. and adjacent Native corporation lands.

Patrol Area:

- Choggiung, Ltd. lands **north of Nushagak Bay** and **west of the Wood River**
 - **Aleknagik Natives Ltd.** (ANL) lands adjacent to Choggiung, Ltd. boundaries
 - ANL lands surrounding and accessible areas around **Lake Aleknagik**
 - **Native Allotments** located within and adjacent to the above areas

Scope of Work:

- Perform **up to 12 patrols per month** during the contract term (Sep–Apr)
 - Provide and maintain your own transportation equipment (e.g., road vehicle, snow machine, ATV)
 - Maintain **valid insurance** on all equipment and operations
 - **Supply own fuel** and maintenance services for field use
 - Use Choggiung, Ltd.'s **Patrol Report Form** to document observations for each patrol
 - Submit **supporting documentation**, including:
 - GPS coordinates
 - Photographs
 - Audio/video recordings of any potential violations or suspicious activity

Compensation:

- The Contractor will be **paid with completed patrol** based on the agreed rate stated in the awarded contract.
 - Payment will be issued following review and approval of patrol reports and supporting documentation.

Minimum Qualifications:

- Prior experience operating safely in remote, off-road, and winter conditions
 - Familiarity with ANCSA land boundaries and permitted uses preferred
 - Ability to use GPS, smartphone, or digital camera to document field observations
 - Self-motivated and able to work independently
 - Strong communication and reporting skills
